

Purchase Agreement and Guarantee

Health Guarantee at time of purchase: Buyer has 3 days from time of purchase to have Puppy examined by a veterinarian. At this time Puppy should be started on vaccination schedule as recommended by Veterinarian. If Veterinarian determines Puppy was seriously ill upon arrival, Puppy may be returned within this time with signed proof of diagnosis on Veterinarian's letterhead and a replacement puppy or full refund for price of puppy will be given. Failure to have Puppy examined within 3 days will void entire Health Guarantee.

12 month Health Guarantee for Genetic Disease: Puppy is guaranteed for the first 12 months of life against any life threatening or life altering genetic disease. No other health problems are included in this agreement. If life threatening or life altering genetic disease is found, Buyer should immediately notify Seller and send diagnosis on Veterinarian's letterhead, signed by Veterinarian. Seller must be notified of the genetic disease during the first twelve months of life. Seller reserves the right to additional opinions by qualified veterinarians of Seller's choice to confirm diagnosis before replacement puppy is given.

24 Month Health Guarantee for Hip Dysphasia: If Puppy is diagnosed as being severely dysphasic on or before 24 months after birth, Buyer will submit the OFA or Penn HIP report to Seller to receive replacement. Only OFA or Penn HIP can make this diagnosis. If OFA or Penn HIP results show that obesity, neglect, over-stress joints, or injury occurred that caused or contributed to dysphasia, no replacement puppy will be provided.

To qualify for Health Guarantee: Buyer agrees to keep Puppy current on all vaccinations and on heartworm, flea and tick preventatives. (Copies of these records will be required by Seller if Buyer is seeking a replacement). Puppy should show no signs of neglect; this includes being malnourished, obese, or having poor hygiene. Puppy should not have sustained an injury of any kind. Buyer agrees to have Puppy spayed/neutered by 6 months old and Seller receiving documentation of this by 8 months. Puppy must not have changed ownership as guarantee is for original owner only. Puppy must be returned to Seller before replacement is given. (In case of death, full Necropsy Report from Veterinarian must be received). Registration papers for Puppy must be signed and transferred back to Seller.

Replacement Puppy: Puppy will be replaced from next available litter. Replacement Puppy will be of comparable or lesser value. If a higher valued puppy is chosen, the buyer must pay the difference in value. Seller's sole responsibility is not to exceed that of comparable priced Replacement Puppy. If Replacement Puppy is to be shipped, it will be at Buyer's expense.

Upon receiving a Puppy from Seller, Buyer assumes all responsibility for the Puppy. All veterinary, transportation, and other expenses for Puppy and Replacement Puppy are the sole responsibility of Buyer. Seller can predict to the best of his ability but cannot guarantee traits, characteristics or physical attributes of Puppy.

Spay/Neuter Agreement: Puppy is being sold as a pet only and not being sold by Seller for breeding purposes (unless breeding rights have been purchased). In case Puppy has not been spayed/neutered by Seller, Buyer agrees to have Puppy spayed/neutered by 6 months of age and send documentation from Veterinarian to Seller by 8 months of age; not doing so will void Guarantee and may result in legal action. Papers for registering your Puppy will be sent when Veterinary documentation of spaying/neutering is received by Seller.

Deposit for a puppy is \$300.00. Deposit will be applied to purchase price and is non-refundable. Original contract must be signed and sent to seller within 10 days of making deposit.

Purchase Price for Labradoodle Puppy described above is _____. Purchase price is to be paid in full at six weeks after birth. Failure to do so will void sale.

Shipping puppy is available to most airports for an additional charge. If shipping puppy, payment is due six weeks after birth. Puppies can be shipped when they are eight weeks old.

Buyer agrees that he/she has read, agrees and understands this purchase agreement and guarantee.
